Agreement and Waiver

By signing below, I understand, agree, warrant and covenant as follows:

- I represent and warrant to Metro Youth Football Association, Inc. ("MYFA") that I have full legal authority to complete this Agreement and Waiver and to register the above-mentioned player (the "Player") for the MYFA tackle football program.
- I have read and understand this Agreement and Waiver and fully understand its terms.
- All information herein is factual to the best of my knowledge.
- The Player is physically and mentally fit and able to participate in the MYFA tackle football program.
- The Player, all relatives, and all people associated with the Player, will follow all rules and regulations of the MYFA tackle football program. As a parent or legal guardian of the Player, I assume full liability for the Player and the Player's activities in the MYFA tackle football program.
- Refunds will not be given on any registration without the approval of the MYFA Board.
- If a Player wears any equipment not provided by MYFA, I understand that MYFA is not liable for any injury or other harm to the Player, or any other individual, stemming from this non- MYFA equipment. I accept full responsibly for any such equipment.
- Events will frequently be held outside and at facilities open to the public. These events will typically be on grass fields where natural and man-made hazards are to be expected.
- Participation in MYFA tackle football program is potentially hazardous. Participation in the MYFA tackle football program carries with it certain inherent risks that cannot be completely eliminated ranging from minor injuries to catastrophic injuries including death.
- As a result of the Player's participation the MYFA tackle football program, I will attribute NO LIABILITY to MYFA, its board members, medical personnel, and its members which may include but is not limited to officials, coaches, commissioners and all parents of players in the MYFA tackle football program.
- I understand that I am giving up substantial rights, including the right to sue.
- I acknowledge that I am signing the Agreement and Waiver freely and voluntarily, and intend it to be a complete and unconditional release of all liability of MYFA to the greatest extent allowed by law.
- I understand and agree that in consideration of being permitted to participate in MYFA tackle football program, I, the Player, the Player's heirs, personal representatives or assigns, do hereby release, waive, discharge and covenant not to sue MYFA for any and all liability from any and all claims arising from the Player's participation in the MYFA tackle football program.
- This Agreement and Waiver shall be governed by, and construed according to, the laws of the State of Iowa. Any disputes under this Agreement and Waiver shall be brought in a court of competent jurisdiction in Linn County, Iowa, and I hereby submit myself and the Player to personal jurisdiction therein.
- If any provision of this Agreement and Waiver is deemed unlawful, void, or unenforceable, then that provision is be deemed severed from this Agreement and Waiver and shall not affect the validity and enforceability of the remaining provisions.
